Members' Unmet Needs

Summary: PerformCare will assess, identify, and address health care and social determinants of health needs in the populations we serve; helping to enable them to live healthier lives and achieve maximum independence. As a PerformCare provider, you deliver health care services to our members. When you submit claims, please add the appropriate ICD-10 codes that identify social determinants of health. With your help, PerformCare will have actionable data and be able to respond to our members' unmet needs. Below are the IDC10 codes and descriptions useful for classifying relevant socioeconomic information valuable for population health.

Background:

At PerformCare, care is the heart of our work. That means that every day we put our members and their families first. We work to improve not only their health, but also the economic and social issues that can act as a barrier to proper care —social determinants of health that are estimated to account for 70% of avoidable mortality¹ in the U.S. alone.

Our mission to build strong, healthy communities goes beyond clinical care. Up to 80 to 90 percent of a person's health is tied to factors other than clinical care.² These factors, known as the social determinants of health, include nutritious food, access to care, safe housing, reliable transportation, and community supports.

These underlying drivers of health impact every part of our physical, mental, and social well-being. When they work against someone or are left unaddressed, they create health inequalities — which lead to worse outcomes and more expensive care.

Social factors, including education, racial segregation and bias, social supports, and poverty, can affect a person's risk factors for premature death and life expectancy. SDoH disproportionately impact low-income individuals and minority populations. As SDoH have a significant impact on health outcomes, addressing the impacts from SDoH is essential to the achievement of greater health equity.

Health care providers who serve our members are uniquely positioned to identify and address SDoH. For example, many behavioral health services (e.g., Assertive Community Treatment, Community Treatment Teams, Family-Based Mental Health, Targeted Case Management, Peer Support Services, Recovery Support Services) already incorporate assessment and service planning related to SDoH. Together we can customize person-centered programs to ensure that our members have the critical support and services they need, so they can make important lifestyle changes and lead healthier, more productive lives.

Action Needed: Please include the appropriate supplemental ICD-10 diagnosis codes on your claim to report SDoH. The inclusion or lack of Z codes will not impact the adjudication of claims or the processing of encounters. PerformCare is requesting voluntary inclusion of the information to assist as part of our analysis of Member needs. Note: SDoH should not be used as the admitting or principal diagnosis.
