

60-79% - 22-28 points	The Treatment Plan is of a higher quality than what is normally considered community standards, and incorporates all of the necessary components of an effective initial assessment.
80-100% - 29-36 points	The Treatment Plan is of significantly better quality than what other Clinicians are completing and conducting. The Treatment Plan incorporates exceptional assessment techniques, methods and interventions, Discharge planning, as well as Crisis planning.
